REG CC – THRESHOLD LIMITS

Effective July 1, 2025 we are increasing the amount available for withdrawal by checks not subject to next day availability to \$275.00 up from \$225.00 and cash withdrawals to \$550.00 up from \$450.00. In addition, the amount available for withdrawal or exception holds for large deposits, new accounts and the amount for determining a repeat overdraft is increasing to \$6,725.00 up from \$5,525.00

WHATS NEW? CHANGES TO FRAUD ALERTS FOR DEBIT CARDS

We have enhanced the security features for debit card transaction notifications you may receive. If a transaction is in question by FALCON, you may receive a telephone call and/or an email from Velera attempting to verify the transaction. They are now utilizing a carousel of telephone numbers you may not recognize, however the Fraud Alert Short Code is **49447**. We recommend you save that number into your contacts on your telephone so you can recognize the caller. The call back numbers will be randomized and you will receive a unique case # to reference when talking to the Fraud Detection live agent. The Email address you may see is; <u>No-Reply@fraud.Velera.com or No-Reply@fraud.PSCU.com</u>. Do not respond to the emails, they are for notification only. You may call the credit union or you may reach a Fraud Detection Live agent at 888-918-7313.

START SAVING FOR CHRISTMAS 2025

July is a great time to open a Christmas Club account! Deposits can be made anytime either at the credit union or by payroll deduction. There is a \$5.00 fee for early withdrawal. On the Wednesday preceding Thanksgiving, a transfer is made from your club account into your primary savings account without a penalty. With a Christmas club account, you can save all year long for Christmas!

IDENTITY THEFT

Identity theft occurs when a thief obtains and illegally uses your identifying information such as you Social Security number or your credit card or checking account numbers to open new credit accounts and / or apply for loans in your name. If you feel you have been a victim of ID theft...below are the 3 major credit bureaus to contact to obtain a free credit report. You are entitled to 1 free report annually from each bureau.
